## Coding for Success

'Coding for Success' is a policy document that sets out the reasons why auto-identification and data capture (coding technologies) is important in healthcare and encourages wider adoption.

The Department of Health (DH) has recommended that the GS1 System should be adopted throughout the healthcare system in England.

The GS1 System of standards provides unique identification for products, assets, returnable assets, locations, clinicians and patients through the use of bar codes and Radio Frequency Identification (RFID) tags.

An efficient healthcare system is all about the right person, right product or medication, right time and right method.

## What are the benefits of auto identification and data capture (AIDC)?

There is evidence of real improvements to patient safety when coding systems are used to match patients to their care:

- Reduced medication errors
- Reduced risk of wrong-site surgery
- Accurate track and trace of surgical instruments, equipment and other devices
- Better record keeping
- Managing supplies and purchasing electronically can cut costs dramatically as well as improve efficiency

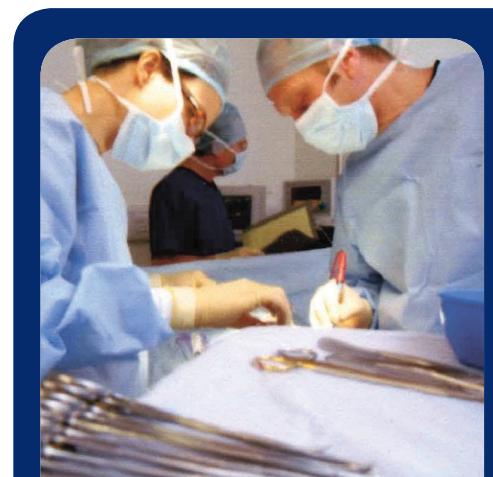

#### 11.25 Why GS1 coding is important for patients

Chris Ranger and Helen Lovell will explain how coding can be used in healthcare to improve patient safety, in particular by reducing avoidable errors such as giving the wrong blood or medication to a patient. They will set out the evidence and describe the DH's recommendations, both to the NHS and industry, for uptake and use of the GS1 coding system plus the importance of standardisation as a basis for introducing coding effectively in patient care. They will give real life case studies to demonstrate the real difference effective use of coding can make to patients with reference to safe patient identification and blood transfusion safety.

#### 14.05 Making it easier to do business with the NHS

Bryan Semple, IT Solutions Director will outline the latest developments which NHS Supply Chain has implemented that support the NHS Coding for Success policy and the NHS Procurement eEnablement Programme (NPEP). Bryan will cover the implementation of a new national catalogue, the adoption of the NPEP and recommendation of GS1. In addition he will explain how this has enabled end-to-end electronic communication between suppliers and NHS trusts across the Healthcare supply chain, thereby driving out costs and inefficiencies while improving customer service and patient safety.

#### 14.30 NHS Trust procurement case study: Leeds Teaching Hospitals NHS Trust and the NHS Procurement eEnablement Delivery Group (NPEDG)

Leeds Teaching Hospitals NHS Trust (LTH) is the largest Trust in the UK and includes the largest teaching hospital in Europe. They provide high quality acute hospital services for the population of Leeds and the surrounding area and act as a regional centre for a number of specialist services such as cancer and cardiac surgery. At the end of 2000 LTH incorporated bar code scanning in their catheter labs which allows clinical staff to get a 'real-time' picture of stock levels. Graham will explain how the system allows information to be scanned not only into a stock inventory system but into the EPR and the finance database. This ensures that every piece of equipment can be traced to every patient and an accurate costing of all procedures can be established.

Chris Slater, Chair of NHS Procurement Enablement Delivery Group will explain how the NPEDG is driving forward the adoption of procurement Enablement technologies across the NHS supply network. He will run through how the NPEP provide a range of initiatives and guidance to drive forward the adoption of procurement eEnablement technologies in the NHS to improve patient safety. Chris will also provide an overview of NPEP and why they have adopted the GS1 System of standards.

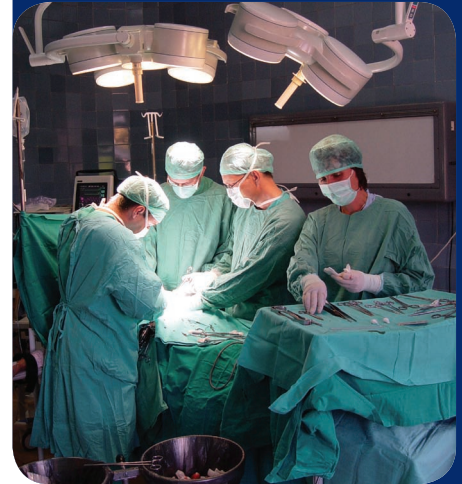
